



# STOP LITTERING APPLICATION

## A Low-Cost Spay/Neuter Program

Spay/ Neutering is an integral part of responsible pet ownership and imperative to helping end unnecessary euthanasia due to pet overpopulation.

CAA has created a low-cost spay/ neuter program for NJ residents, which utilizes a partnership with People for Animals' Low Cost Spay/Neuter Clinic. There are two tiers to the program, with various qualification factors. CAA believes that all pet owners should have access to affordable spay/neuter surgery. You must complete all of the information on this form to participate in the CAA Stop Littering Program and receive a spay/neuter certificate.

### PROGRAM OPTIONS

#### I. CAA No Fee Certificate Program:

Pet owners, that are NJ residents with pets under 7 years of age, that receive assistance through CAA's Feed-A-Pet Program administered through the Center for Food Action, qualify for a free spay/neuter voucher, supplied by CAA, with the surgery performed at the People For Animals Spay/Neuter Clinic located in Hillside, NJ. This program is also available to senior citizens.

#### II. CAA Partial Fee Certificate Program:

Pet owners, that are NJ residents with pets under 7 years of age, can purchase a certificate through CAA, that can be utilized at the People For Animals Spay/Neuter Clinic located in Hillside, NJ. This certificate will allow the pet owner to obtain services at a 50% discount of the usual low PFA fees. Program is subject to financial qualifications
